**5 The management committee of Saint Mary's Cathedral has agreed to table the following amendment:**

1. Section 6.2.2 Associate Membership
2. Religious organisations whose community activities complement the priorities or activities of PPN members.
3. Remove this text and leave religious organisations be full members as per section 6.1.1 as currently written

**a) There was some discussion about this tabled amendment – merits and appropriateness of religious organisations being PPN members; why this has arisen; don't at least some religious organisations meet full membership criteria; is it unfair to exclude any groups that meet PPN membership criteria; this is an unexpected situation**

**b) It was clarified that the key difference between Full Members and Associate Members is that Full Members have voting rights.**

**c) This has arisen as it was copied from another PPN constitution (but is not in the national PPN user guide)**

**d) Proposed by Jim Prior that this amendment be deferred and voted on at next Plenary meeting, seconded by Aisling Lohan and agreed to by the Plenary**

**6 The Board of Garryowen CDP wishes to table the following amendment to the draft constitution of the Limerick PPN:**

1. SECTION: 7.2.4 Criteria for Secretariat Membership
2. Add the following: *A person who has put themselves forward for nomination to be elected, stood for election or who has been an elected representative on any level of government (local or national) may not be chosen to be a member of the Secretariat for a period of twelve (12) months after the date on which they were advised that their bid for nomination was unsuccessful, or, in the case that they were nominated, twelve (12) months from the date of the election or, in the case that they were elected, twelve (12) months after completing their term of office.*

2. It should be made clear in the preamble that PPN while PPN staff are employed and hosted by LCCC, they are managed by the PPN through the Secretariat.

**8 The Board of Garryowen CDP wishes to table the following amendment to the draft constitution of the Limerick PPN:**

1. SECTION: 8.2 Principles Governing PPN Representation
2. Add the following: *In the event that the original nominating body no longer exists, or the representative is no longer associated with that nominating body, the representative will be deemed to have stepped down from the role and an alternate will be selected in accordance with the Constitution.*

- **Clarified that the alternative representative will be selected as per the constitution (i.e. from an established panel or through agreed nomination/election process)**
- **Clarified that while a PPN representative is representing the PPN on external committees, they are in this position because their own group/organisation is a member of LPPN**
- **Proposed by Trish Forde Brennan, seconded by Geraldine Minogue and adopted by the Plenary**

**9 The Board of Garryowen CDP wishes to table the following amendment to the draft constitution of the Limerick PPN:**

1. SECTION: 8.6.1 Criteria for candidates for election to external committees
2. Add the following: *A person who has put themselves forward for nomination to be elected, stood for election or who has been an elected representative on any level of government (local or national) may not be chosen to be a PPN Representative for a period of twelve (12) months after the date on which they were advised that their bid for nomination was unsuccessful, or, in the case that they were nominated, twelve (12) months from the date of the election or, in the case that they were elected, twelve (12) months after completing their term of office.*

<p><b>Election for PPN Representative to sit on Implementation Advisory Group for the Directly Elected Mayor</b></p>	<p>JB gave some background on the PPN seat on the <a href="#">Implementation Advisory Group for the Directly Elected Mayor with Executive Functions</a>. There were 3 candidates for the election, however 1 withdrew from the election. ## Secretariat's report to the Plenary

JB presented the Secretariat's report to the Plenary as follows (this report was circulated on the night):



# Secretariat Report to Plenary Meeting of 10<sup>th</sup> February

## 1 Background

### 1.1 Election of Secretariat

Secretariat was elected on 30<sup>th</sup> October

### 1.2 Expectations from Plenary

The plenary had 3 Key Expectations:

- Briefing on Local Authority and PPN Structures
- Election of Secretariat
- Nomination onto SPCs

## 2 Achievements

Through 5 meetings of the Secretariat and intervening work since our election, the following has been achieved

### 2.1 Constitution

A constitution has been drafted for ratification, considering probable changes in guidelines from government.

### 2.2 Nomination to the Advisory Group for the Directly Elected Mayor

At the request of the Department of Housing, Planning and Local Government for a PPN representative, the Secretariat sent a member to the first two meetings of this group to maintain a watching brief until an election for a PPN representative could be organised. Members engaged positively in the process to date. The Secretariat stressed the importance of rigorous public consultation at the initial meeting. PPN has been listed as a key stakeholder in the dissemination & PR process as part of the next steps for public consultation.

### 2.3 Registration

Currently 104 members have been successfully registered. Breakdown of these is:

## 2.4 Previous PPN and Secretariat

The Secretariat received advice from the local authority that the Secretariat has no responsibility for any outstanding issues relating to the previous Secretariat, which was a Company Limited by Guarantee.

## 2.5 Relations with the Local Authority

The Secretariat acknowledges:

- The local authority's assignment of Mary Casey to provide additional support
- Huge amount of work put in by Mary and Mo Foley-Walsh in supporting the PPN
- Support of Seamus O'Connor as the designated Liaison Officer for the PPN
- Relationship with LC&CC soon to be formalised through an Memorandum of Understanding

## 3 Challenges

### 3.1 Starting Point

Need to recognise that the Secretariat started with a governance vacuum. Therefore, priority was the constitution.

### 3.2 Legal Status

- Received correspondence regarding potential legal action against the Secretariat.
- Need to clarify legal status of PPN and Secretariat
- Secretariat and PPN depends on working environment based on trust and confidentiality

### 3.3 Secretariat Membership

- 3 Vacancies:
  - Adare Rathkeale Municipal District X1 (6 members can vote)
  - Community X1 (58 members can vote)
  - Environment X1 (8 members can vote)
- Secretariat members remain committed to the PPN objectives and to creating a better and more efficient working environment.

## 4 Recommendations for Plenary

### 4.1 Independent Governance Advice and Support

- Clarification of legal status
- Dispute resolution mechanism

### 4.2 Priorities for Coming Months

1. Briefing on Council and PPN Structures
2. Elections for SPCs
3. Developing mechanism to strengthen relationship between elected PPN reps and membership
4. Election of Secretariat members for vacant seats
5. Agreement on workplan for the year

Following the report there was some discussion. The key points are as follows:

- a) It was noted that the number of resignations was high in such a short timeframe.
- b) It was clarified that the resignations of 3 Secretariat members and potential legal action are not related to any legacy issues prior to the election of the current Secretariat.
- c) It was clarified that there is still a representative on the Secretariat from the Environment Pillar.
- a) Priority 4.2.3 (developing a mechanism to strengthen relationship between elected PPN reps and membership): this is about the Secretariat looking at the best ways to support elected PPN members in their representative role and to support strong engagement of the PPN membership. More concrete proposals from the Secretariat will be brought to the Plenary
- b) It was clarified that the Secretariat have been in contact with the Chief Officer of Limerick LCDC and there are current vacancies and possibly near-future vacancies on the LCDC. It is up to the Chief Officer/LCDC to contact the PPN requesting PPN representation and as soon as the Secretariat can action this, it will happen.
- c) It was noted that there are currently 3 PPN representatives on the LCDC who are recognised for being very valuable LCDC members. The Secretariat are conscious that there is currently no supportive structure to come back to. The Secretariat needs to consider options to present the Plenary on how best to do this (eg. Secretariat undertake this role).
- d) It was clarified that the two LPPN staff members are LCCC staff. The resource worker is ‘interim’ and part-time. The support worker is full-time. There is dedicated funding for two full-time staff. The Secretariat recommended not changing the employment relationship of the LPPN staff, with the PPN/Secretariat not becoming an employer with all the associated responsibilities. However, the PPN through the Secretariat manages the staff. While called an interim role, no time-limit has been set by LCCC on the current resource worker. The staffing situation is one that the Secretariat is actively monitoring.
- e) It was noted that the Memorandum of Understanding is very important for clarifying roles and responsibilities of the different parties to the PPN
- f) It was noted that it is likely to be the May 2020 Council meeting that the PPN needs to have names of PPN representatives for the different SPC’s. The Council ratifies the PPN representatives but cannot veto PPN nominations.
- g) Under recommendation 4.1 of the report, JB on behalf of the Secretariat, requested agreement from the Plenary for the Secretariat to pursue any necessary options to clarify the legal status of the Secretariat and PPN, to clarify governance and accountability issues and identify and establish a suitable dispute resolution mechanism. JB clarified that the question about accountability in the event of a legal challenge is likely apply to PPN’s nationally, so the DRCD will need to be approached. Essentially, this is about clarifying the roles of LCCC and DRCD and LPPN in the governance and accountability of LPPN and to ensure best governance practice is followed. JB emphasised that this is very important for the Secretariat members who are very committed to their role. Trish Forde Brennan proposed that the Secretariat being approved for this activity. This was seconded by Aisling Lohan and was adopted by the Plenary.
- h) The work of the Secretariat was acknowledged
