## **Consultation Focus Group: Local Economic Community Plan feedback**

EG gave a great explanation of the LECP, first initiated in 2015. She was part of the Focus Group held on Wednesday 10<sup>th</sup> March 2021. The Department of Rural & Community Development



wish to develop new guidelines. These should be released in the near future but no specific date is available as yet.

Going forward EG believes we as a group should familiarise ourselves with the whole LECP consultation process. DT agreed to put a link on chatter and it was agreed to have this item on the next agenda

#### Climate Action and Biodiversity Environment Linkage group Proposal

The correspondence below was read by Edel and it was unanimously agreed that we as a group support the topic. Edel agreed to check with Liz Gabbett of Climate Action and if it is supported by all PPN Linkage groups, we will query if it is going just from the Linkage group or as whole PPN

"Hi Limerick Climate Action and Biodiversity Environment Linkage Group

At our linkage group meeting, 29th March 2021, I asked for support from those present to put forward a letter to the Local Community Development Committee detailing the realities of community groups struggling to cover core administration costs. Here is the proposed letter. I would appreciate your feedback and confirmation of your support for the letter, or not.

Dear Members of the Local Community Development Committee,

Limerick Climate Action and Biodiversity Environment Linkage Group wish to bring to your attention that local community groups are struggling to cover core administration costs, e.g. insurance, bank charges, accountancy costs, etc. We ask that you recommend to council and government departments who set the rules for funding opportunities allow for core administration costs to be submitted and considered in funding applications.

In the past, community groups and local NGOs would have run events that allowed them to raise money from the public support that goes towards the running costs of an organisation. Necessary COVID-19 restrictions have made these events impossible to host.

On top of the fundraising event restrictions, lack of insurance cover or increasingly very expensive insurance costs are making many community group activities impossible. The number of insurance underwriters in the Irish market has been severally reduced due to Brexit. These three factors alone are just some of the many reasons for increasing insurance costs but the effect at the local level is that many community groups who support and provide events and facilities that enhance our quality of life and environment will not be able to do their core activities and may cease to exist.

In conclusion, we reiterate our request, please can you recommend to council, government departments and agencies who set the rules for funding opportunities allow for core administration costs to be submitted and considered in funding applications.
