Local Updates

National PPN Conference

This year's **National PPN Conference**, will be hosted by Wicklow PPN and Wicklow County Council and held on **Thursday 5th and Friday 6th of October 2023** in the Arklow Bay Hotel, Co Wicklow.

This year's conference will provide an invaluable networking opportunity for Resource Workers, Support Workers, PPN Secretariats, Local Authority staff, elected representatives and others to share experiences and learn from one another. It will also provide an opportunity for the PPN National Advisory Group and the Department to meet with stakeholders and discuss the latest developments in relation to PPNs.

If you would be interested and available to attend this conference, please let us know. Priority will be given to PPN Staff, the Secretariat, Representatives and our Council liaison, as we will have a limited number of passes available.

As you will be aware, an independent Structural Review of the PPNs was carried out in 2021/2022. It recommended a number of actions to make PPN structures work more effectively.

A Working Group was created to consider these recommendations, representing PPN staff and volunteers, as well as government officials and the community sector. This group has developed a draft Implementation Roadmap drawing on the recommendations as well as actions suggested by members of the PPN community. The actions listed are not final at this time.

The Department of Community and Rural Development (DRCD), in collaboration with the Working Group, has now commissioned Crowe to conduct a consultation on the draft Implementation Roadmap.

As a first step, you are invited to read the Draft PPN Implementation Roadmap, which can be downloaded <u>HERE</u>, and to take part in a survey on it.

Crowe have developed the survey to give all those involved in or with PPNs an opportunity to have their say on the draft Roadmap. Feedback from this survey will be used to help finalise the Roadmap.

Limerick Directly Elected Mayor

The Cabinet approved the legislation which will open the way for voters to directly elect a Mayor of Limerick.

More than four years after the people of Limerick approved plans for an executive mayor in a plebiscite, government has finally signed off on the plans for the new office.

It's anticipated the first time the Limerick public will go to the polls to elect a new first citizen will be on the date of next summer's local and European parliament elections.

These are expected to take place on Friday, June 7th 2024.

Funding Opportunity

Minister O'Gorman invites applications under the What Works Building Evidence Fund 2023

Grants of up to €50,000 will be made available to community and voluntary sector organisations working with children and young people through a prevention and early intervention approach. The total value of the fund is €600,000.

These grants will support organisations to support the effective use of data in service provision for children and young people around Ireland. This funding is being made available through the What Works prevention and early intervention initiative which receives its funding from the Dormant Accounts Fund (DAF). The DAF is managed by the Department of Rural and Community Development.

Minister for Children, Equality, Disability, Integration and Youth, Roderic O'Gorman has today announced the creation of a new fund under the What Works prevention and early intervention initiative, which is funded through the Dormant Accounts Fund. The What Works Building Evidence Fund has been established to support the gathering and analysis of data and evidence within the community and voluntary sector.

The Fund is open to practitioners and service providers working in not-for-profit organisations who work with children, young people and their families and who have a strong emphasis on prevention and early intervention.

Not-for-profit organisations are invited to submit applications for funding of up to €50,000 for prevention and early intervention projects that will identify gaps in service provision and develop skills for effective monitoring, evaluation and analysis of prevention and early intervention services.

The Fund further aims to help those working with children, young people and families to access training on collecting, research and analysis that improves outcomes for children and young people.

Community Climate Action Fund

In cooperation with the Department of the Environment, Climate and Communications, Limerick City and County Council will support communities to stimulate and affect real change in the area of climate action through the Community Climate Action Programme. The overarching aim of this programme is to build low carbon, sustainable communities that will contribute to Limerick City and County's climate target.

The Community Climate Action Programme grants can fund up to 100% of all eligible costs. There are three levels of funding available to apply for:

- Small scale projects < €20,000
- Medium scale projects €21,000 to €50,000
- Large scale projects €51,000 to €100,000

Limerick City and County Councils Climate Action Plan

Limerick City and County Council is required to prepare a Climate Action Plan that shall specify the mitigation and adaptation measures that are required to deliver a 51% reduction in carbon emissions by 2030 and carbon neutrality by 2050.

The Limerick Local Authority Climate Action Plan (LACAP) will actively translate national climate policy to local circumstances and Limerick City and County Council will be responsible for reducing greenhouse gas emissions from across our own assets and infrastructure, whilst also taking on a broader role of influencing and facilitating others to meet their own targets.

As a first stage in this process a Climate Action Plan Summary report has been prepared that provides a summary of the evidence that will inform the development of the strategy. This evidence base includes a Climate Change Risk Assessment for County Limerick and a Baseline Emissions Inventory for County Limerick and also for the proposed Decarbonisation Zone. In addition, the report provides an indicative Vision and Mission for the LACAP.
