

Community Climate Action Programme Phase 2

Community Climate Action Programme Strand 1 will be open for applications from 21st October at 10am and will remain open until 5:00pm on 16th December 2025. The online application portal is accessible through this link: Home | Limerick City & County Council's Online Consultation, Survey and Application Form Portal, The application will be available only during the dates specified.

The overall objective of the Community Climate Action Programme is to support and empower communities, in partnership with Limerick City and County Council region, to shape and build low carbon, sustainable communities in a coherent way to contribute to national climate and energy targets. The Programme aims to support small and large, rural and urban communities to take positive climate action.

The community-based projects/initiatives will take action across at least one, preferably several, of the following five themes: Community and Energy; Travel; Shopping and Recycling; Food and Waste; Local Climate and Environment.

Up to 100% project funding may be provided from the Climate Action Programme. Other funding may be leveraged for projects (e.g., with LEADER, Tidy Towns, Town and Village Enhancement funding, etc.) although that is not a requirement of this programme. Pre-funding is available if required and a clear need has been demonstrated.

Three online sessions will take place in the month of November to go through the application in detail and to answer any questions. dates and times of these online webinars will be advised soon through Community Climate Action Programme | Limerick.ie



Music Capital Scheme 2025



The scheme supports funding for the purchase of musical instruments and selected items of equipment to individual professional performing musicians and non-professional groups across the country.

A total of €1,040,000 in funding is available through the following three awards which are now open for applications:

- Music Capital Scheme Award 1 supports the purchase of musical instruments by non-professional performing groups
- Music Capital Scheme Award 2 supports the purchase of musical instruments by individual established professional performing musicians
- Music Capital Scheme Award 3 supports the purchase of musical instruments by individual emerging professional performing musicians

The Scheme is now open for applications and the deadline for applications is 2pm, Thursday 27 November 2025.

The HSE has developed a Free, easy-to-access online programme called 'Balancing Stress' to support people across Ireland in managing common mental health difficulties including stress, anxiety and low mood.

The HSE has developed a Free, easy-to-access online programme called 'Balancing Stress' to support people across Ireland in managing everyday mental difficulties such as stress, anxiety, low mood and worry.

The Balancing Stress programme offers six online video sessions (each around 35 minutes) covering key topics including managing stress, worry, anxiety, low mood, and relationship stress. This online programme offers people evidence-based tools to manage stress effectively and enhance their mental wellbeing.

The programme is delivered by Dr Niamh Clarke, HSE Principal Psychologist, and features expert interviews with Professor Alan Carr, UCD School of Clinical Psychology.
